The Antelope Valley (AV) Community Reentry Center (CRC) at D.O.O.R.S provides an array of comprehensive supportive services to address the barriers to reentry for justice-involved individuals, particularly those on adult felony supervision, their families and the community. Such services include but are not limited to housing, employment, legal aid, educational support, mental health assessment and linkage, substance use counseling, and health and healing through the arts. The services are provided in a welcoming environment by county partners and community-based organizations that are considered leaders in reentry and experienced professionals with high risk communities.
